- This application will be considered active for six (6) months. If the request for additional information has not been addressed within this time frame, the application will be deemed to have lapsed. A fee will apply for the works completed to date or for the re-instatement of the application.
- **Termination of Appointment** The appointment of the RBS may be terminated by the owner only with the written consent of the Victorian Building Authority. On such termination the RBS shall be entitled to be paid all outstanding fees and disbursements incurred.
- **Fees**
 - a) I agree that a non-refundable fee is payable to GBA upon signing the application form.
 - b) Applications will not be processed until the non-refundable deposit has been paid. The invoice will be issued upon lodgement and sent to the applicant
 - c) Building Permits will not be issued until the building permit fee, council fees and government levies have been paid in full.
 - d) Failure to pay fees when due will incur additional costs and the applicant shall be liable to pay any debt collection fees and costs that may arise as a result of late or non payment of fees.
 - e) Building Permit fees quoted and/or invoiced to you are only valid for 60 days. Should the Permit not be issued within that period, GBA reserves the right to alter the permit fee in line with market prices.
